The following questions were received for the RFP – Fire Suppression Testing and Inspection Services. The Question Responses are provided below;

Q1. Will all the work be performed during normal hours?

A1. Yes, 7:00AM to 3:30PM, Monday through Friday.

Q2. Will we have access badges? So we can move around.

A2. Temporary badges are issued daily at the Command Center for all contractors.

Q3. Will an Alarm technician be onsite during testing?

A3. Command and Engineering Technicians are available during the day shift, 7:00AM to 3:30PM to assist with this work.

Q4. The RFP lists full flow trips for the dry systems in 2022 and 2025. They are actually due in 2023, and 2026 per City code. And the last contract year in the RFP is 2025. Can we get clarity for pricing purposes?

A4. The following schedule has been revised. Due to the time required to service the equipment for the 5-year testing, the work will be done in 2025 with service report documentation submitted for the City certification in 2026.
