## LIGHTING COORDINATION NOTES

- 1. REFER TO LIGHTING FIXTURE SCHEDULES ON DRAWINGS EL501 THROUGH EL504 FOR ALL SPECIALTY AND BACK-OF-HOUSE LIGHT FIXTURE DEFINITIONS.
- 2. COORDINATE WITH REFLECTED CEILING PLAN (RCP) DRAWING SERIES A6.10 AND FOLLOWING FOR ALL CEILING HEIGHTS AND EXACT LOCATIONS FOR CEILING MOUNTED LIGHT FIXTURES.
- 3. COORDINATE WITH ARCHITECTURAL BUILDING ELEVATION DRAWING SERIES A-300 FOR EXACT MOUNTING HEIGHTS OF ALL OUTSIDE BUILDING MOUNTED LIGHT FIXTURES.
- 4. FOR MOUNTING ORIENTATION OF ALL COVE MOUNTED LIGHTING IN TOILET ROOMS (FS-1 & FS-2 FIXTURES) REFER TO ARCHITECTURAL DETAILS G12 & A14 ON DRAWING A-670. (TYP)
- 5. FOR MOUNTING ORIENTATION OF ALL COVE MOUNTED LIGHTING IN CORRIDORS, PRE-FUNCTION AND OTHER PUBLIC CIRCULATION AREAS, (FW-2 & FW-4 FIXTURES) REFER TO DETAIL E12 ON DRAWING A-670. (TYP)
- 6. FOR MOUNTING ORIENTATION OF ALL DOWNLIGHTS AT MEETING ROOM ENTRANCES AND WINDOWS, REFER TO ARCHITECTURAL DETAILS E1, E6, L1 & L6 ON DRAWING A-670, AND DETAILS G1 & G6 ON DRAWING A-671. (TYP)
- 7. FOR MOUNTING ORIENTATION OF ALL QUARTZ WALLWASHER 'QW-1' FIXTURES IN PUBLIC CORRIDORS, REFER TO ARCHITECTURAL DETAIL AS ON DRAWING A—671. (TYP)
- 8. WHERE APPLICABLE TO LIGHTING INSTALLATION, UTILIZE THE STANDARDS AND GUIDELINES OUTLINED ON 'MISC ELECTRICAL DETAILS' DRAWINGS EP401, EP402 AND EP403.
- 9. ALL 'C-EM' FIXTURE MOUNTED IN STAIRWELLS SHALL BE WALL MOUNTED AT 7'-0" ABOVE LANDING. COORDINATE WITH ALL OTHER TRADES FOR INSTALLATION OF OTHER EQUIPMENT IN STAIRWELLS, E.G. FIRE PROTECTION FCVA LOCATIONS, ETC.
- 10. MANY OF THE SPECIALTY LIGHTING FIXTURES HAVE SPECIFIC CONSTRUCTION AND MOUNTING REQUIREMENTS. TO REVIEW THIS INFORMATION, REFER TO FIXTURE MANUFACTURER'S CUTS PACKAGE AT END OF LIGHTING SPECFICATIONS


